**Invitation to Bid for the Labor and Materials for the Rehabilitation/Improvement of Road at Old Road, San Jose Village, San Jose, City of San Fernando, Pampanga**

The City Government of San Fernando, Pampanga, through the Approved Budget 2010 intends to apply the sum of **FOUR MILLION SEVEN HUNDRED NINETY EIGHT THOUSAND ONE HUNDRED THIRTY ONE PESOS & NINETY THREE CENTAVOS ONLY (P4,798,131.93)** being the Approved Budget for the Contract (ABC) to payments under the contract for **CSFP-C10-10-2845**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The City Government of San Fernando, Pampanga now invited bids for **MOBILIZATION/DEMobilIZATION, BILLBOARD, HEALTH AND SAFETY, EMBANKMENT, SUB-GRADE PREPARATION, AGGREGATE BASE COARSE, 6" THK. PCCP**. Completion of the Works is required **60 calendar days**. Bidders should have completed, ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from the City Government of San Fernando, Pampanga and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be purchased by the interested bidders on **NOVEMBER 12, 2010 (Friday) until 5:00 pm of NOVEMBER 18, 2010 (Thursday)** from the address below and upon payment of a non refundable fee for the bidding documents in the amount **FOUR THOUSAND SEVEN HUNDRED NINETY EIGHT PESOS & THIRTEEN CENTAVOS ONLY (P4,798.13)**.

The City Government of San Fernando, Pampanga will hold a Pre-Bid Conference on **NOVEMBER 19, 2010 (Friday) 10:00 a.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **10:00 a.m of DECEMBER 01, 2010 (Wednesday) at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instruction to Bidders (ITB) Clause 18.

Bid opening shall be on **DECEMBER 01, 2010 (Wednesday) 10:30 a.m. at CGSO Building, New Public Market, Del Pilar, City of San Fernando, Pampanga** will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The City Government of San Fernando reserves the right to accept or reject any bid to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
