

Executive Order No. 2004-16

**AN ORDER DECLARING JANUARY 31 TO FEBRUARY 5, 2005 AS
"KAGANAPAN 2005" AND CREATING THE 4TH CITYHOOD ANNIVERSARY
CELEBRATION COMMITTEE**

WHEREAS, the City of San Fernando is celebrating the fourth anniversary of its establishment as a component city on February 4, 2005;

WHEREAS, "ing siyudad ning kekatamung paninap" - the motto of the campaign for cityhood in 1997 to 2000 - has become a reality resulting into the "kaganapan" of our dreams;

WHEREAS, the conversion of San Fernando into a city resulted in increased economic activities and additional revenues for the city paving the way for improved delivery of services to Fernandinos, the construction of important structures and the preservation of significant sites in the city; and

WHEREAS, to ensure the success of the anniversary through appropriate events and ceremonies that will perpetuate the significance of the event, there is a need to organize an Executive Committee and Sub-Committees and specify the general functions and duties.

Now, therefore, by the powers vested in me by law, I, Oscar S. Rodriguez, City Mayor of the City of San Fernando, do hereby order as follows:

Section 1. That January 31 to February 5, 2005 is declared as week of "KAGANAPAN 2005" to celebrate the 4th cityhood anniversary of San Fernando, Pampanga on February 4, 2005.

Section 3. That the Executive Committee of the Cityhood Anniversary shall have the following functions:

1. to call the committee to regular and special meetings at date and time agreed by the members of the executive committee.
2. together . with the sub-committees, plan and organize a meaningful commemoration of the 4th anniversary of the cityhood of San Fernando.
3. propose to the local executive the inclusion of additional members to the subcommittees through board resolutions signed by the executive committee members
4. raise funds and solicit support to the cityhood anniversary celebrations.

Section 4. This Executive Order shall take effect immediately.
