

RESOLUTION NO. 2004-035

RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) FOR THE ESTABLISHMENT OF AN INTEGRATED SCHOOL AT PANIPUAN, CITY OF SAN FERNANDO, PAMPANGA

WHEREAS, in the pursuit of effective delivery of basic services particularly to the youth in the provision of quality elementary and secondary education, the Punong Barangays of Panipuan, Malino and Baliti, this city, together with the representatives of the Department of Education have consolidated their efforts to initiate the establishment of an Integrated High School in the northern part of the City of San Fernando, Pampanga;

WHEREAS, after a thorough study and deliberation among the Punong Baranganays involved, the area of Barangay Panipuan was chosen to become the site of the proposed Integrated High School, the area being the most strategically located not to mention the availability of a two-hectare property of the city government by virtue of donation for the purpose;

WHEREAS, the establishment of an Integrated School in the northern part of the city would undoubtedly enhance the literacy rate in the area and would mitigate the ill-effects of the present economic crisis particularly among low-income families who can not afford sending their children to private schools in the neighboring Angeles City;

WHEREAS, under the Memorandum of Agreement (MOA), the City Government shall provide funds for the operation and maintenance of the Panipuan Integrated School for at least five (5) years or until such time when funds for said purpose are incorporated in the national budget; the construction of a three (3) classroom School building and facilities together with furniture, equipment and textbooks thereon;

WHEREAS, the city government shall also provide funds for the salaries of teachers at the rules equal to those of nationally paid teachers or at rates approved by the local school boards;

WHEREAS, the Department of Education through the School's Division Superintendent shall take charge of the administration and supervision over the Integrated School subject however to the existing DepEd orders and policies;

WHEREAS, the School's Division Superintendent shall also submit to the DepEd Regional Office an annual status report of the Integrated School;

WHEREAS, upon motion of the Honorable Jaime T. Lazatin duly seconded by all the Sangguniang Panlungsod members present,

NOW THEREFORE, the Sangguniang Panlungsod of the City of San Fernando, Pampanga in session assembled,

RESOLVED as it is hereby resolved to authorize the City Mayor to enter into Memorandum of Agreement (MOA) for the establishment of an Integrated School Panipuan, City of San Fernando, Pampanga

RESOLVED FURTHER that a copy of this Resolution be furnished to all concerned parties to the Memorandum of Agreement
