

## **RESOLUTION NO. 2004-039**

### **RESOLUTION AUTHOURIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DepEd) FOR THE ESTABLISHMENT OF AN INTEGRATED SCHOOL AT BARANGAY LARA, CITY OF SAN FERNANDO, PAMPANGA**

**WHEREAS**, in the pursuit of effective delivery of basic services particularly to the youth in the provision of quality elementary and secondary education, the Barangay Council of Lara, this city, together with the representatives of the Department of Education have consolidated their efforts to initiate the establishment of an Integrated School in the northern part of the City of San Fernando, Pampanga;

**WHEREAS**, after a thorough study and deliberation with the members of the Barangay Council, the area of Barangay Lara was chosen to become the site of the proposed Integrated School, the area being the most strategically located not to mention the availability of a one thousand four hundred sixty-square meter property available for use for its site;

**WHEREAS**, the establishment of an Integrated School in the northern part of the city would undoubtedly enhance the literacy rate in the area and would mitigate the ill effects of the present economic crisis particularly among low-income families who can not afford sending their children to private schools in the neighboring Angeles City;

**WHEREAS**, under the Memorandum of Agreement (MOA) the City Government shall provide funds for the operation and maintenance of the Barangay Lara Integrated School for at least five (5) years or until such time when funds for said purpose are incorporated in the national budget; the construction of a school building and facilities together with furniture, equipment and textbooks thereon;

**WHEREAS**, the city government shall also provide funds for the salaries of teachers at the rates equal to those of nationally paid teachers or at rates approved by the local school boards;

**WHEREAS**, the Department of Education through the School's Division Superintendent shall take charge of the administration and supervision over the Integrated School subject however to the existing DepEd orders and policies;

**WHEREAS**, the School's Division Superintendent shall also submit to the DepEd Regional office an annual status report of the Integrated School;

**WHEREAS**, upon motion the Honorable Jaime T. Lazatin, chairman on the Committee on Education duly seconded by the Sangguniang Panlungsod members present,

**NOW THEREFORE**, the Sangguniang Panlungsod of the City of San Fernando, Pampanga in session assembled,

**RESOLVED** as it is hereby resolved to authorize the City Mayor to enter into a Memorandum of Agreement (MOA.) for the establishment of all Integrated School at Barangay Lara, City of San Fernando, Pampanga

**RESOLVED FURTHER** that a copy of this Resolution be furnished to all concerned parties to the Memorandum of Agreement,
