AN ORDINANCE CREATING BARANGAY PULUNG BULU AS THE 35TH BARANGAY OF THE CITY OF SNA FERNANDO, PAMPANGA AND APPROPRIATING THE NECESSARY FUNDS THEREOF.

WHEREAS, Pulung Bulu is a recognized existing barrio of San Fernando, Pampanga on or before 1950;

WHEREAS, its residents were forced to transfer temporarily to other neighboring barangays at the height of the Huk Rebellion in Central Luzon, consequently, it was demolished as a barangay through Municipal Resolution No. 06, series of 1965;

WHEREAS, upon restoration of the peace and order situation, residents returned to Pulung Bulu and clamored for the revival/creation of their original barrio known as Pulung Bulu; several legislative undertakings were initiated and pursued, but all yielded negative results;

WHEREAS, the conversion of the former municipality of San Fernando into a component city which was ratified by the Fernandinos last February 4, 2001 through a plebiscite called for the purpose, clothed the latter with the power to create a barangay;

WHEREAS, a careful study and a series of consultative meetings with the Lands and Management Bureau of the Department and Environmental and Natural Resources (LMB-DENR), Provincial Statistics Office, City Officials of San Fernando, Interim Officials of Pulung Bulu, Barangay Councils of Telabastagan, Panipuan, Malino and Baliti, etc., were conducted;

WHEREAS, the subject barangay has satisfactorily satisfied all criteria set forth under Section 386, R.A. 7160 to with:

a) Population - at least two thousand inhabitants. Based on the May 2000 census, Pulung Bulu has 2, 811 inhabitants as certified by the NSO Provincial Office and with the separation of the inhabitants of Pulung Bulu, Barangay Malino still maintains the minimum requirement prescribed by law;

b) Land Area - no definite area required. As per boundary computation based on a survey in 1917, it has an area of 253 hectares and 2,353 sq. m. and it is properly identified by metes and bounds;

c) Income - no specific income required, but it has an existing trust fund in the amount of P313,322.10 as of July 2001 as certified by the

City Treasurer of San Fernando, Pampanga and such income is sufficient to provide basic services and facilities to meet the requirement of the populace;

WHEREAS, upon motion of Honorable Raul F. Macalino duly seconded by all the Sangguniang Panlungsod Members present,

NOW THEREFORE, the Sangguniang Panlungsod of the City of San Fernando, Pampanga in session assembled,

BE IT RESOLVED as it is hereby resolved that the Sangguniang Panlungsod of San Fernando, Pampanga creates and adopts the following Ordinance:

Section 1. - Title

AN ORDINANCE CREATING BARANGAY PULUNG BULU AS THE 35TH BARANGAY OF THE CITY OF SNA FERNANDO, PAMPANGA AND APPROPRIATING THE NECESSARY FUNDS THEREOF.

Section 2. - Scope and Application - This Ordinance shall exclusively apply to the territorial jurisdiction of Barangay Pulung Bulu, being the 35th barangay of the City of San Fernando, Pampanga and particularly identified with existing boundary monuments as follows:

1. **DBM 66 (boundary between Pulung Bulu and Barangays Baliti and Telabastagan ;**
2. **DBM 67 (boundary between Barangay Pulung Bulu and Barangay Baliti);**
3. **DBM 65 (boundary between Pulung Bulu and Panipuan);**
4. **MBM 9 (boundary between Pulung Bulu and Angeles City and Panipuan); and**
5. **MBM 8 (boundary between Barangay Pulung Bulu and Angeles City and Barangay Telabastagan)**

Section 3. - Repealing Clause

Ordinances, orders or Regulations inconsistent with this Ordinance are hereby amended or repealed accordingly.

Section 4. - Separability Provisions

If for any reason, any section of this Ordinance, or any portion hereof, or the application of such section, provisions or portion hereof, or the application of such section, provision or portion hereof to any person,

group or circumstance is declared invalid or unconstitutional, the remainder of this Ordinance shall not be affected by such declaration.

Section 5. Effectivity Clause

This Ordinance shall take effect after the approval by the City Mayor and ratification through plebiscite to be held for this purpose on October 30, 2002 by the residents of Barangay Baliti and Malino, the latter being considered as the Mother Barangay.

The Commission on Election (COMELEC) of the City of San Fernando, Pampanga shall conduct the said plebiscite and the City of San Fernando through the Sangguniang Panlungsod hereby authorizes the City Mayor through the City Treasurer to defray the necessary expenses for the conduct of this plebiscite, the necessary appropriation of which shall be debited from whatever funds available.
